Overview

The city council's Energy Resilience Act 2024 mandates 2-hour storage for all new solar installations above 5MW. Georgia's final energy. With solar capacity growing 18% annually since 2022 and wind projects multiplying across Kakheti region, Georgia's capital faces a renewable integration crisis. The national grid operator recently reported 127 hours of renewable curtailment in Q1 2025 alone—enough wasted energy to power 12,000. The funds will provide an operating subsidy to projects for each kWh of energy they discharge into the electricity market during peak demand hours when there is typically a shortage of renewable energy generation. 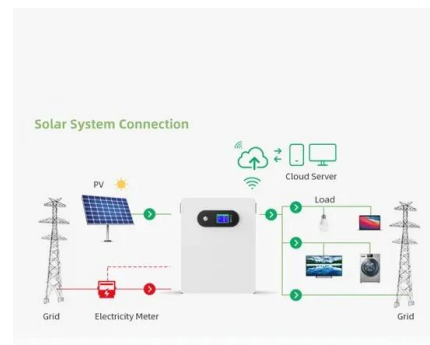
